Mr. Sprow moved, Mr. Pepple seconded, to elect Mr. Long as Chairman of the Board of Public Affairs for 2017 and Ms. Ford as Vice Chairman of the Board of Public Affairs for 2017. Roll call vote: all ayes; nays, none. Motion carried.

Director of Utilities Berner reviewed a few items for the January 3, 2017, Board meeting as well as advising the Board of the Bryan Area Chamber of Commerce banquet being held in January. Further discussion was held.
