SCHEDULE "R"

RESIDENTIAL SINGLE PHASE SERVICE

<u>AVAILABILITY AND APPLICABILITY</u>: This Schedule is available and applicable for only single-phase service supplied through no more than 25 kVA of installed transformer capacity, to what is ordinarily designated and recognized as individual Single Family Homes, Apartments, Mobile Homes, and other individual Single Family Dwelling Quarters. Where service is supplied through one meter to more than a single family dwelling unit or living quarters or apartment see "Multiple Dwelling Units" as to billing procedure.

All service under this Schedule shall be single phase delivered through a single set of service wires, the service location to be designated by City.

This Schedule is not applicable for service utilization that is ordinarily considered by public utility operation as being Non-Residential, Non-Home, or Non-Farm use in character. Where the installed nameplate rated transformer capacity exceeds 25 kVA or where 3-phase service is furnished, City's General Service Schedule "GS" shall apply.

Where electric service is supplied for combined Residential and Non-Residential use, the General Service Schedule "GS" shall apply for all such single metered service. However, at Consumer's option and at his expense, the wiring may be separated (subject to City's inspection and approval) and each class of service separately metered and billed in conformance to the applicable schedule.

All applications for service shall be in accordance with the provisions of City's Standard Application Form and in accordance with the provisions set forth in this Schedule and also in accordance with City's General Rules and Regulations for subsequent revisions thereof on file at the City's Utility Office, which General Rules are a part of this Schedule as if fully written herein.

NET RATE PER MONTH OR PART THEREOF PER SERVICE

The Monthly Billing shall be the sum of the charges set forth below:

RATE "R"

Service Charge: \$ 10.25 PLUS Outside Surcharge: \$ 3.75 (If Applicable) PLUS Energy Charge: 9.83¢/kWh

> PLUS \$3.50 per kW of Capacity In Excess of 20 kW (When City Elects to Install Capacity Meter)

EXCISE (KILOWATT-HOUR) TAX ADJUSTMENT: The rates and charges set forth in the City's electric rate schedules shall be increased by an amount equal to the excise (kilowatt-hour) tax imposed on the City's electric distribution system under Ohio Revised Code § 5727.81. Said increase shall be automatically adjusted to reflect any change in the kilowatt-hour tax imposed by Ohio Revised Code § 5727.81.

<u>MONTHLY MINIMUM CHARGE</u>: The Monthly Minimum Charge per Consumer before adjustments, shall be the sum of the applicable charges set forth above.

<u>ADJUSTMENT TO APPLY TO RATES AND MINIMUM CHARGE</u>: The foregoing Rates and Minimum Charges shall be subject to increase to the extent that the provisions and adjustments apply as is specified elsewhere under Rider "A," Power Supply Cost Adjustment and Tax Cost Adjustment, Monthly Minimum Charge, Billing for Multiple Dwelling Units, and Seasonal Service.

<u>OUTSIDE SURCHARGE</u>: The Outside Surcharge set forth above shall be applicable to all Consumers receiving service under this Schedule where the premises being served is located outside the City corporation limits.

<u>SEASONAL SERVICE</u>: Seasonal Service shall be defined as service that is furnished for normally less than 12 months to homes, cottages, mobile homes, farm labor camps, cabins, wells, etc. Such seasonal service will be furnished only where Consumer's premises are located immediately adjacent to City's distribution facilities. Any line extension required will be subject to City's regulations and requirements pertaining to same. Such Seasonal service shall continue for not less than six consecutive months each time service is established. City's Trip Charge shall apply each time that service is

Connected or Disconnected. All such service applications shall be in the name of the Property Owner.

<u>MULTIPLE DWELLING UNITS</u>: The Schedule is applicable where not more than one dwelling unit, apartment, living quarters, mobile home or activity is supplied through one meter.

Where more than one dwelling unit or activity is served through one meter, for billing purposes, the Service Charge and the kWh used and applicable Minimum Charge shall be multiplied by the number of dwelling units or activities served through one meter. Where four or more living quarters or dwelling units are served through one meter and for future dwelling units that are not separately metered, City's Schedule "GS" shall apply.

<u>POWER SUPPLY AND TAX ADJUSTMENTS</u>: The Rates and Charges set forth in the Schedule are subject to the Adjustments set forth in City's Rider "A" and same shall apply.

<u>TERMS OF PAYMENT</u>: The above rates and other applicable charges are Net as shown and already reflect the discount given from the Gross Rates if all accounts due and payable are paid on or before the final payment date specified on bill. If all accounts are not so paid, the Gross Rates shall become payable which are 10% but not less than \$1.00 higher than the foregoing Net Rates.

If any bill is not paid within 30 days after the payment date specified on bill, service shall be subject to disconnection as provided in City's Rules and Regulations and any Reconnection of Service shall be subject to the City's Trip Charge.

<u>BUDGETED TERMS OF PAYMENTS</u>: Upon the request of the Consumer who utilizes electric service for the "All Electric" home, and upon the approval of the City, a Budget Plan for the payment of electric service bills may be elected by Consumer. Based on actual experience (or estimated kWh consumption where there is not actual experience), the City will compute the annual electric service bill for all purposes and divide same by 12. The result shall be the amount to be paid by Consumer as his "Average Monthly Budget Bill." The annual billing period ends with the July regular meter reading date and the difference between the billing for the kWh actually used by Consumer and the amount actually paid under the Budget Plan shall be reflected in the following August bill, which will be in addition to the regular budgeted billing. Any overpayment will be credited to Consumer's future billing.

OTHER TERMS AND CONDITIONS:

- 1. <u>Application For Service and Responsibility For Payment of Bills</u>: Where premises are occupied by a Tenant, City reserves the right to require that the Application for Service be in Property Owner's name who shall be responsible for the payment of all bills. In such an event, the bill may be mailed direct to the Tenant, with a copy to the Property Owner. The Tenant may be required to make a suitable Deposit to secure bill payment. However, such Deposit is for Property Owner's protection and in no manner will such Deposit relieve Property Owner of his responsibility for payment of bills.
- 2. <u>Application For Temporary Service</u>: For Temporary Service, City's General Rules and Regulations shall apply. City reserves the right to require that Applications for Temporary Service be in the name of the Property Owner, who shall pay all electric service bills. Each time that service is established, same shall be subject to the City's applicable "Turn-On" and "Turn-Off" trip charge for Temporary Service.
- 3. <u>Character of Service Furnished</u>: The type of service furnished under this schedule shall be single phase at a nominal potential of approximately 120/240 volts, 3wire or at the sole option of City, 120 volts, 2-wire service may be furnished. The size of individual motors shall not exceed 15 HP nameplate rating except where written permission is granted by the City. City reserves the right to require that all motors 10 HP and larger shall be equipped with reduced voltage starting equipment so as to avoid unnecessary voltage fluctuations on the City's system.

This Schedule is not applicable for 3-phase service. If 3-phase service is supplied, City's Schedule "GS" shall apply to all service—both single- and 3-phase.

- 4. <u>Use of Service</u>: Service under this Schedule shall not be resold or shared with others, except as provided under "Multiple Dwelling Units."
- 5. <u>Other Charges For Special Services</u>: See City's Rules and Regulations as to charges not set forth herein, applicable for the Disconnection and Reconnection of Service and the Charges to be made for other Special Services furnished Consumers.
