Public and Media Relations Manager Pendleton informed the Board that recent donations in the amount of \$6,190 had been received by Northwest Ohio Community Action for the

Good Neighbor Fund which assists those struggling to pay utility bills. She continued that over \$86,000 had been received by generous donors since the program began.

Communications Superintendent Ferrell advised the Board that while negotiations between the National Cable Television Cooperative and AMC were settled on January 1, 2016, the ultimate effect on our local cable television lineups is still unknown. Price increases may impact the current cable rates and/or which channels are to be included in the lineups. In March, the issue will likely need to be addressed by the Board.
