BRYAN BOARD OF PUBLIC AFFAIRS

June 3, 2025

Board of Public Affairs Chairman Annette Schreiner opened the meeting of the Bryan Board of Public Affairs with the following members present: Robert Eyre, Karen Ford, Richard Long, and James Salsbury. Also present were: Director of Utilities Derek Schultz, Mayor Carrie Schlade, Communications Superintendent Joe Ferrell, Bryan City Council Member John Betts, and Clerk-Treasurer John Lehner.

Director of Utilities Schultz commented on the recent passing of Communications Technician II Patrick Wilde and requested a moment of silence in his memory.

Mr. Long moved, Mr. Salsbury seconded, to approve the minutes of the May 20, 2025 Regular Meeting, as written. Roll call vote: all ayes; nays, none. Motion carried.

Resolution No. 19, 2025, titled,

RECOMMENDING BRYAN CITY COUNCIL REJECT ALL BIDS RECEIVED FOR THE SALE OF THE COMMUNICATIONS HFC SYSTEM

was presented and read by title only. Director of Utilities Schultz explained that upon receiving only one bid in the amount of \$236,977, he and Communications Superintendent Joe Ferrell felt the price was too low, and that the system could possibly be put to another use or attract a larger bid at some point in the future.

Mr. Eyre moved, Mr. Long seconded, to pass Resolution No. 19, 2025. Roll call vote: all ayes; nays, none. Motion carried.

Resolution No. 20, 2025, titled,

A RESOLUTION ESTABLISHING A COMMITTEE OF THE WHOLE STRUCTURE FOR THE BRYAN BOARD OF PUBLIC AFFAIRS

was presented and read by title only. Director of Utilities Schultz explained this is in line with recommendations the Board received from City Attorney Marc Fishel at its last meeting. Each Committee will be assigned a single Chairperson and will have the opportunity to meet as needed.
